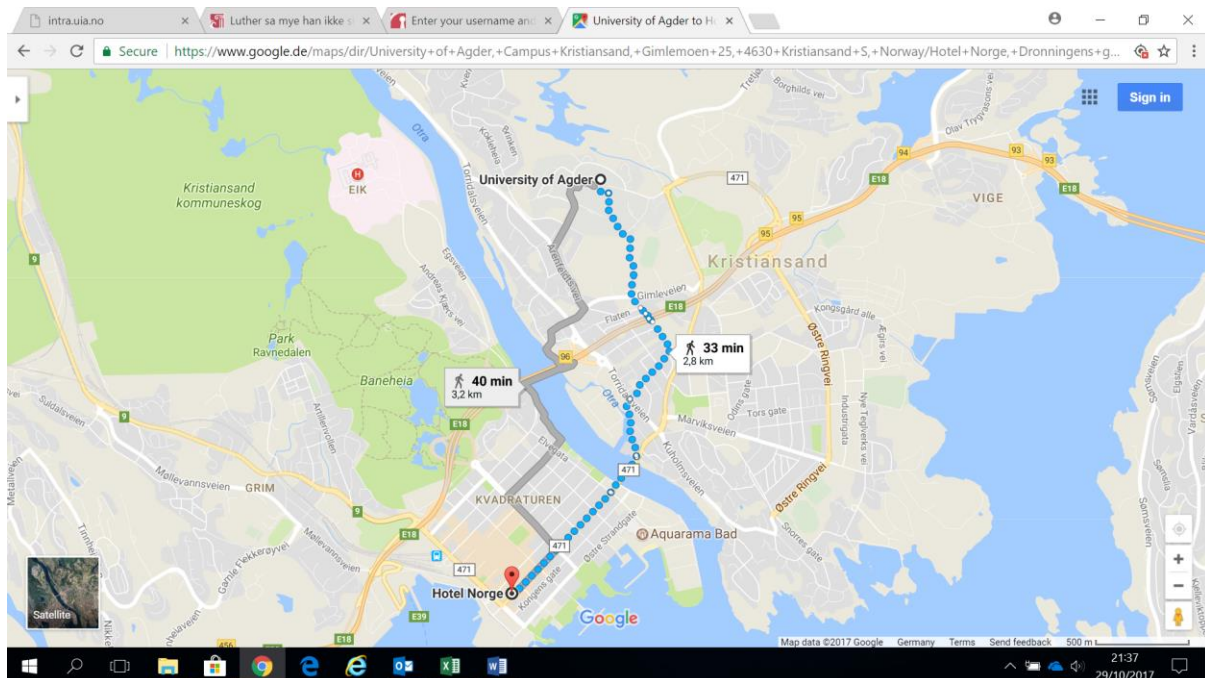

How to get from the airport to the Hotel Norge?

The bus schedule is at <http://www.akt.no/english> (enter 'Kvadraturen' as destination). You may also check the schedules right at the entrance of the 'Kjevik' airport arrival hall. Tickets (one way) cost approximately 40 NOK. There are ATM machines in the main hall of the airport. Taxis are relatively expensive and will cost app. 350 NOK (depending on the time of the day).

The Hotel Norge.

We reserved a room for you at the **Hotel Norge**, well known for its excellent breakfast (serving self-backed bread amongst other things). You may take a look at <http://www.hotel-norge.no>.



How to get from the Hotel Norge to UiA?

It takes approximately 35 minutes to walk from your hotel to campus, but you can also take a bus (which will take 10 minutes). Most bus lines – departing at the intersection of Henrik Wergelands gate and Markens gate – serve UiA (you need to get off the bus at UiA/Spicheren). How to get to the bus stop? On leaving the hotel through the main entrance, turn left, then left again into Markens gate and continue for about three minutes. The bus stop is about five blocks away.
